1. Prepare and file current returns, however, we can refer you to agencies that may assist you with filling.

1. Identification
2. Social Security Card
3. Proof of Income
4. Copy of the tax returns you filed for the years involving any dispute, problem or controversy
5. Tax bill/ Notices from the IRS or the U.S Tax Court
6. Letters submitted to the IRS on your behalf.
